Comrades,

We are pleased to share that Moneris, the official supplier of debit and credit card processing for Legion Branches, has extended their agreement with the Legion to continue offering Branches with additional savings on payment processing.

To apply for the preferred payment processing rate program, Branches can fill out the attached rate sheet and email it to Moneris-SalesLeads@moneris.com. Branches can also call Moneris directly at 1-888-552-0341 and reference, “The Royal Canadian Legion Branches.”

In early March, Moneris lowered their rates for Legion Branches from 0.12% to 0.10%. Existing Branches to the program received a notice in February and do not have to take action, as these rates were automatically applied on March 2, 2026.
